HS MISSION: To develop students who are Confident Learners, Cross-Cultural Navigators, and Caring Community Builders and to provide all students with the knowledge, skills and character to graduate from high school and the confidence to continue on and successfully complete their post-secondary education.

HS BOARD EXPECTATIONS: Be respectful of time. Be open to communication. Be transparent to students and families. Make intentional changes. Set time limits. Be prepared.

HS BOARD 24-25 BOARD GOALS:

Confident Learners:

- Commit to high academic expectations and improve academic achievement by at least 10 percentage points by grade level on all three MCA assessments by centering on Data Driven Instruction
 - o 10% increase in MCA Reading for each grade level tested
 - o 10% increase in MCA Mathematics for each grade level tested
 - o 10% increase in MCA Science for each grade level tested
- School directors will report on academic achievement and growth via formal curriculum reports on formal assessments (Fastbridge and MCA IIIs) twice a year.

Caring Community Builders:

- Maintain a 25% fund balance at the end of the fiscal year
- Ensure a clean FY25 audit as determined by the school's auditors
- Ensure the school receives the FY25 Finance Award, as determined by the school's accountant

Cross Cultural Navigators:

- Evaluate the relationships of the School with staff and with families using the Insight surveys in January (staff) and May (families).
- Evaluate the relationships of the School with the broader community through anecdotal information reported at the board level

Craig Kepler, HS Counsel, Presentation on The Roles and Responsibilities of the HS Board in relationship to the HSBC Board

- Mr. Kepler
 - What is ABC stand alone nonprofit organization.
 - Soul purpose for owning property that can be leased to schools



- Own board of directors
 - No Employees
- Charter schools may not use state money to purchase land or buildings.
- 1997 Lease aid was introduced to help pay rent.
- Tax exempt revenue bonds
 - Lower fixed interest rate
- Supporting Organizations
 - support an existing 501c3
- Charter School is the sole voting member for ABC
 - 100% control of ABC board
 - Can remove or appoint members
- 6 Consecutive years
- positive net fund balance past 3 years
- long range projection plan
 - 5 years
- Plan that describe budget
- ongoing responsibility of School Board
 - appoint directors to ABC Board
 - 1 year terms
 - Minimum of 3 directors
 - ABC has very little to do with school operations or during quiet times.
 - Can't have board overlap
 - Can't have high level admin on board
 - Financial Service Provider have opted to not have members on board
 - Dr. Henderson asked about facility management costs
 - Does the school board need to approve those costs? or can the ABC make those choices?
 - Lease says property board should pay
 - School should request services
 - Who has authority to make payments?
 - Board has to approve budget and audit
 - Authority is implied in the budget of the school board
 - Dr. Myers asked if there is a line in the budget saying how much the ABC has to spend?
- ABC board has to appoint officers after members are appointed
- Approving the audit
- ABC Directors, Minutes of Meetings etc... are posted on website
 - Conflict of interest items that applies to ABC directors
